How Denuvo and Small Impact Games Battle Cheaters in the Gaming Industry

This case study delves into the collaborative effort of <u>Small Impact Games (SIG)</u>, an independent video game developer, and Denuvo by Irdeto, a leading provider of cybersecurity solutions. The study highlights the challenges faced by the gaming industry due to cheaters and explores how <u>Denuvo by Irdeto</u> has advanced anti-cheat technology which helps SIG maintain fair and enjoyable gameplay for its players.

<u>SIG was founded in 2013</u> by Mitchell Small, James Rowbotham, and Cameron Small, as a game development studio based in Leicester, England. The company boasts a team of 12 skilled developers who have previously worked for renowned companies like Electronic Arts and Rocksteady Studios. In 2022, SIG released its first-person shooter game, <u>Marauders</u>, which gained popularity among gamers worldwide.

The Impact of Cheaters

Cheating has become a pervasive issue in the gaming industry, causing significant disruptions and damaging the gaming experience for honest players. Cheaters exploit third-party tools and modifications to gain unfair advantages, creating an imbalance in multiplayer games. This is often frustrating for players that don't cheat, and eventually honest players may begin abandoning the game in favor of titles with a fairer gaming experience.

Cheating has far-reaching consequences which extend beyond immediate gameplay frustrations. When cheating occurs, it leads to a significant drop in player engagement. Over time, this results in a decline in the active player base and a potential loss of game revenue. According to <u>Irdeto research, the annual</u> global online gaming market is estimated to be about US\$37 billion. When 78% of gamers are put off by a game because of cheating, this means nearly US\$29 billion of revenue is at stake! <u>Nearly half (46%) of players say they're less likely to buy in-game content if there's cheating.</u>

The financial implications of cheating are clear and moreover, games that are known for struggling with cheaters also suffer from reputational damage, attracting fewer new players. The adverse effects can be even worse for publicly traded companies, as news of rampant cheaters can impact their stock market valuations. Cheating tarnishes a game's reputation, lowering trust and loyalty among its players.

If cheating is a fact of life, it needs a solution, and the best one is employing anti-cheat technology. This approach involves the development of sophisticated systems capable of detecting and preventing cheating in various forms. By addressing cheating head-on, gaming companies can foster a fair and enjoyable gaming environment for their players.

With SIG, it was no different. Cheaters started to infiltrate and grow in number within its first-person shooter game, Marauders.

"We wanted to keep the gaming experience fair and enjoyable for our players, but at the same time, we were facing an ever-increasing threat from cheaters. It was crucial for us to secure an anti-cheat supplier that understood the complexity of the issue, and that could harness the power of analytics to root out these bad actors.", said Mitchell Small, Managing Director at Small Impact Games.

To address the industry-wide cheating problem impacting Marauders, SIG had employed the use of a famous free anti-cheat service, focused on countering hacking and cheating in multiplayer PC games through the use of hybrid anti–cheat mechanisms. The experience with that previous anti-cheat service was not positive – the software did not perform well, it yielded false positives without providing evidence on detections, and SIG's team felt a lack of support throughout the process, which led to enormous frustration.

After hitting the market again for a better solution, the company turned to Denuvo by Irdeto. Denuvo, which is renowned for its cutting-edge anti-cheat technology, provided real-time cheat detection, with imperceptible impact on game performance and comprehensive support.

Denuvo's anti-cheat solution monitors gameplay on PC using hardware security features and gameagnostic machine learning. Unlike other anti-cheat technologies on the market which automatically ban without sharing any information, Denuvo's proactive monitoring identifies and flags unauthorized thirdparty programs or modifications, allowing game developers to take appropriate actions against cheaters whether it be banning, sending them to 'cheaters island' or other measures.

The Success of Denuvo Anti-Cheat

Upon integrating Denuvo by Irdeto Anti-Cheat software, SIG witnessed remarkable results. Within a few months, Denuvo identified and thwarted 26 different types of cheats in Marauders, including wall and camera hacks, lag switches, aim bots, and currency manipulation: cheats that were all undetected by the free anti-cheat software previously used by SIG. Denuvo's transparent data sharing, with full cheat evidences, has empowered the gaming studio to make well-informed decisions regarding cheaters. The system also allows customers to check the solution is really working and not producing false positives.

When SIG ran into more technical cheats, the anti-cheat team at Denuvo by Irdeto was able to promptly find new ways to stop them. Keeping direct contact with counterparts at SIG and providing fast response times made a difference in the battle against cheaters.

The ease of integration and transparency of Denuvo's product made life easier for SIG's developers – who could instead focus on creating player-centric experiences without worrying about cheat-related issues.

Denuvo Anti-Cheat's exceptional features and capabilities stand out in the industry. The solution offers real-time cheat monitoring without disabling debugging, making it efficient and unintrusive. Additionally, all cheat detections occur server-side, preventing tampering by clients.

The anti-cheat device fingerprinting technology prevents repeat offenders from circumventing detection. At the same time, its installation is limited to competitive aspects of the game, leaving single-player and non-competitive modes unaffected. Furthermore, Denuvo's AI learning continuously evolves to detect new cheating attempts as they emerge.

According to James Rowbotham, Game Developer at Small Impact Games, Denuvo by Irdeto has been a game-changer in the battle against cheaters and in the quest to ensure fair gameplay. "After optimizing the anti-cheat tool, we found the game's performance was the same, and the evidence given by Denuvo for identification and banning cheaters has made our lives much easier."
