Cheaters are an unfortunate inevitability, especially when it comes to competitive games with solid player bases. This equates to money in the eyes of cheat developers and resellers. Ubisoft considers all modifications or software allowing players to benefit from an unfair advantage towards other players unacceptable and subject to banning. This includes cheating, hacking, botting, farming and save/file/ client modifications, even if done just for the excitement. Exploits, impersonations, stream and queue sniping, toxicity and threats of any kinds are also unacceptable.

Online multiplayer games attract some of the best players in the world, and winning games is incredibly hard. Losing because you get eliminated by a cheater is a frustrating experience and, if it happens often enough, can quite literally drive a game's player base away as people leave for games that have fewer cheaters. Cheating in the online versions of games takes away from the fun and experience of those who are legitimate players.

Cheat developers are at the root of the cheating problem as they are actively creating cheats that circumvent fair game play, at a lucrative price. Unfortunately, some gamers want cheats and are willing to pay to have an unfair advantage. Targeting both the cheaters and the cheat developers is something that Ubisoft and Denuvo focus on identifying and removing.

## The Solution Presented by Denuvo by Irdeto

PC gamers have most likely played against a cheater. Denuvo by Irdeto has taken a multi-faceted approach to curb cheating, offering a tailored solution that includes finding not only the advertised cheats but exploits wherever they appear, infiltrating open and closed groups where cheats are sold. Denuvo also tests and validates these cheats and the vulnerabilities they exploit. Once identified, the publisher reviews and addresses those vulnerabilities, resulting in sanctions that discourage cheaters from reoffending. Other times, we are able to render the cheat invalid, requiring new development from cheat developers, who are not always motivated to keep trying to update the same cheat. In essence, Denuvo is breaking the cheater's business model.

Cheat detection is a cat-and-mouse game and improving the speed and accuracy of any detection system to stay one step ahead is an integral part of a winning anti-cheat strategy. Denuvo alerts Ubisoft about the cheats and shares the telemetry data to improve the detection accuracy. This early knowledge adds another layer to Ubisoft's detection system and an edge in alerting and monitoring such unfair tactics.

Because of enhanced investigation processes to close in on cheat developers, it becomes increasingly difficult for them to find a workaround to anti-cheat technologies and release new cheats. These efforts have been successful and have resulted in a significant decrease in cheat developers interfering with protected titles. As a result of the Denuvo anti-cheat solution implemented by Ubisoft, a total of 112 cheat developers to date have been identified and nullified.

Our team's work with Ubisoft to develop another layer of protection and identify suspicious behavior trends is a constant battle against cheaters, and we have achieved great outcomes by working together.
